Mr. Young-Hall, provided the board with a year to date financial update. The department is currently under spent with 80% of all full time staff positions filled, 20 staff positions are in the recruitment phase and 17 staff positions ready to be posted for recruitment.

Mr. Ruddock provided the board with a current bill tracker as part of his verbal update. He also reviewed current legislation that the Health Department supports or opposes. The legislative session is currently about half way through the 2023 session, with multiple bills still working their way through the process.

8. Executive Director's report

Dr. Weidenbach provided the board with a written Executive Director report before the board meeting and provided a few verbal updates as well. March is National Nutrition month, Dr. Weidenbach acknowledged and shared her support of all Women, Infant and Children (WIC) and Nutrition educators. She informed the board a few upcoming events. National Public Health week is April 3rd thru 7th. On Monday, April 3 the Board of County Commissioners (BOCC), County Managers Office and Board of Public Health members will tour several of the Health Department locations. A proclamation with The BOCC will issue a proclamation in support of public health on April 4 and can be viewed through the counties youtube channel. Dr. Weidenbach will be presenting to the BOCC in the next few weeks to request 12 additional full time staff positions that are a result of 2.3 million dollars in received grant funding. The department is waiting on updates for an additional 2-3 grants that have been applied for.
