**RESOLUTION ADOPTING REGULATION NO. BA-22 – BODY ART ESTABLISHMENTS**

**Resolution No. 2022-003**

**WHEREAS**, the Adams County Board of Health (“Board of Health”) serves as the governing body of the Adams County Health Department (“ACHD”) that will function as Adams County’s public health agency beginning in January 2023; and

**WHEREAS**, the Board of Health has proposed Regulation No. BA-22, Adams County Health Department Rules and Regulations for Body Art Establishments (“Regulation BA-22”); and

**WHEREAS**, C.R.S. §25-4-2101, et. seq., (the “Body Art Act”), sets forth a regulatory structure for the practice of Body Art; and

**WHEREAS**, pursuant to the authority granted in the Body Art Act, the State Board of Health of the Colorado Department of Public Health and Environment has adopted Rules and Regulations for Body Art Establishments, 6 CCR 1010-22 (“CDPHE Regulations”), which establishes the standards for Body Art Establishments and the practice of Body Art; and

**WHEREAS**, pursuant to the Body Art Act, as well as C.R.S. §25-1-506, C.R.S. §25-1-508 and C.R.S. §25-1-509, the Board of Health of ACHD is authorized and empowered to adopt rules and regulations which establish standards for Body Art Establishments and the practice of Body Art; and

**WHEREAS**, a copy of the proposed Regulation BA-22 has been reviewed by the members of the Board of Health, a copy of which is attached hereto as Exhibit A, and incorporated herein by reference; and

**WHEREAS**, ACHD has given the general public twenty (20) days written notice of the time and place of the public hearing to review Regulation BA-22 prior to adoption by the Board of Health; and

**WHEREAS**, the Board of Health held a public hearing on October 20, 2022, to consider adoption of Regulation BA-22 and Board of Health desires to adopt Regulation BA-22.

**NOW, THEREFORE BE IT RESOLVED** that after proper notice and a public hearing as required by applicable law, the Board of Health hereby adopts Regulation BA-22 in the form attached hereto as Exhibit A, on the 20<sup>th</sup> day of October 2022, to be effective as of January 1, 2023.
